It gives members more power to adjust the rules according to the current needs of the association and its members.

An election of the new SCCA board - all positions are open for election this year again. Please, read your latest proposed by-laws draft to see what responsibilities each board member has according to a proposed by-law. This is your chance to actively participate in the Sandcastle Community Association as a board member, director or an officer.

### **Vice President Message**

Hello Members,

It looks like summer is almost here, the foliage is lush and our parks look good. Thank you to all of our parks volunteers.

The task of rewriting our by-laws to be compliant with Ontario regulation and to modernize the operation of the association, is progressing. A "Special Meeting" was held on May 18 where it was voted in favour to hold a mail in ballot for all



Members. You should have received this ballot in the mail by now. We will be counting the votes July 1st and if a majority of people vote to replace our current by-laws, we will hold a ratification vote at our AGM in August. These ballots may be returned to any executive, or sent in the mail. If both the mail in vote and the ratification vote, are in favour of replacing our current by-laws, our replacement by-laws will take effect three weeks after the AGM. This will fulfill our compliance requirement with the government.


Also, at the AGM in August, we will be voting on the acceptance of rules and regulations for Members. These rules will be supplied by Members and everyone is encouraged to participate in the forming of these rules. Please email me with your ideas, edits, new rules, or your support or non-support for the rules and regulations proposals.

The rules and regulations are easier to change than amending a by-law. It is possible to amend the rules and regulations from time to time as we require.

#### **Rules Proposals**

The rules that have been proposed are:

- SCCA is a volunteer operated not for profit association. All Members are expected to participate in the operation of the association.
- The purposes of the SCCA are:
- to maintain the real property that it owns,
- to advance nature conservancy and biodiversity on that property.
- to promote the non-commercial interests of persons owning property in the Subdivision,
- To establish rules and regulations governing the conduct of Members when using property of the association.
- The SCCA will charge and collect annual levies and fees as set by Members. Failure to pay these charges will result in the cancellation of membership.
- Members are responsible for themselves, their immediate family relatives and guests while they are using SCCA parks and trails. It is expected that Members, their families and guests, respect and cooperate with any safety or security measure(s) that are implemented by the association.
- Restrictions to the use of parks and trails belonging to the association, by commercial guests, may be imposed. \*\*(this refers to rental guests please provide your comments) \*\*
- Members must receive permission to use SCCA property for personal events such as family reunions. Guests are prohibited from using SCCA property for personal events.



### **Vice President Message**

- All motorized vehicles, gas or battery powered, are prohibited from the SCCA trails, and beachfront parks. When human powered bicycles are operated on SCCA property, they will at all times yield to pedestrians.
- Fires, BBQs and fireworks are prohibited on SCCA parks and trails.
- Camping is not permitted in SCCA Parks or Trails.
- Dogs must be leashed at all times while on SCCA trails or parks. All dog waste to be immediately removed, by handler, from SCCA parks and trails.
- Chairs, sun umbrellas, personal effects or any type of watercraft may not be left overnight in any of SCCA beach-front parks, and all garbage, including cigarette butts, must be removed from the property by the party responsible for its production.
- Members will not operate motorized water craft in the area adjacent to the beach area of SCCA parks. Boats will not be parked or stored in these areas for the safety of swimmers.
- Noise shall be controlled on SCCA property so as to not disturb other users, or adjacent property owners. This shall include amplified sounds, dogs barking, yelling.
- Any act which could cause harm or intimidate others, is prohibited at any time on SCCA parks or trails
- Do not dispose any yard waste, leaves, or garbage from your property in any of the SCCA parks or trails.
- Construction debris that has blown into the park is to be removed immediately by the member whose property is under construction.
- Invasive plants (ie Periwinkle) to be contained within the member's property, to protect and conserve our natural environment.
- Do not install lighting that may disturb other property owners. If lights are necessary, direct them down and away from neighbouring properties and install motion sensors to prevent lights being on all night.

As was mentioned at our meeting on May 18, our previous insurance provider, made the decision to no longer renew the existing insurance coverage for the association. We have managed to find another similar policy. While we reviewed the coverage, it was discovered that we did not have coverage for any activity involved in the launching of a boat.

The actual boat ramp, the concrete pad designed for vehicles, is not on our property. It would also appear that we have no written approval to use this area for the purpose of automotive traffic or boat launching. The area that we do own, which provides access to the concrete ramp, is not insured for automotive traffic.

The result has been to close the access to vehicles on our property, as we do with all of our other property. Pedestrians, who are Members, may carry inflatable boats, kayaks, canoes or other light craft, through our property and into the water at any

point along the beach.

The SCCA has proposed that should there be a request from Member boaters to use our property for automobile traffic, that they form a separate boaters' group that can navigate the legality, safety and insurance needs required. Please email me if there is any interest in forming a boaters' group.

At our AGM in August, we will be electing a new Board of Directors to operate the SCCA. From the Directors, a Chair and

President will be selected. These Directors will also appoint Officers such a Vice President, Secretary Treasurer Parks Officer and Members Officer.

Anyone wishing to be a SCCA Director, is asked to fill out an application and submit it to the executive by August 1. This will allow the Members to be advised of available candidates when the agenda for the meeting is published.

And if all of the above is not enough, Tiny has established by-laws that we should be aware of. They include not operating ATVs or golf carts on Tiny roadways, no unnecessary night lighting (dark sky initiative), no shoreline alterations, no boats operating or parked in front of their beaches and there are others. For a complete list and the actual wordings please see Tiny.ca. Tiny Connect is available to send updates directly to your devices. Tiny has also proposed a new Town Hall which could affect our taxes, for both the association and the Membership.


## Parks Director Message
